PRESENTER

The webinar program is presented online by Dr. Stephan Foster, PharmD, FAPhA, FNAP. He also serves as the APhA liaison to the Advisory Committee on Immunization Practice (ACIP) and is nationally known for his work on pharmacist-provided immunization. Dr. Foster is on the Speakers' Bureau for Merck, Pfizer, Seqirus, and Sanofi-Pasteur; he serves on the Advisory Board for Pfizer, Dynavax and Valneva.

- Describe engineering and work practice controls that can help minimize exposure risks
- List the hepatitis B vaccination requirements for health care workers
- Outline the proper post-exposure response
